This game can be played in two levels of difficulty.

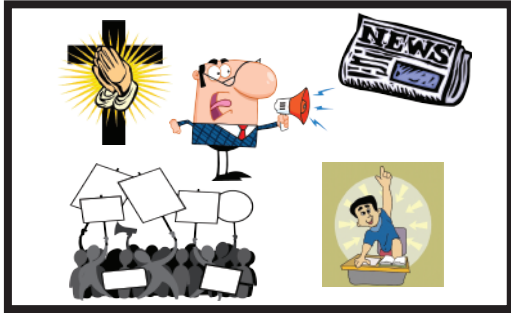
